With the limitation in resources especially in manpower to conduct research, advocacy does its research through surveys and in partnership with organisations and the Solomon Islands Government (SIG). 3.2 SICCI Advocacy Key Achievements in 2023

3 meeting for Manufacturing Industry Working Group (MIWG).

Monthly meeting of the MIWG to discuss issues and challenges impacting the growth of the manufacturing industries in the country. These were convened to enable members to discuss issues impacting the growth of manufacturing industries in the Solomon Islands and to decide on the recommendations to put forward to the government for consideration when implementing policies for the manufacturing industry in the Solomon Islands.

3 meetings for Building Construction Industry Working Group (BCIWG)

Meeting for BCIWG enabled members to discuss issues impacting the growth of building and construction practices in the Solomon Islands and to decide on recommendations to present to the government for consideration when implementing policies supporting the building and construction practices in the Solomon Islands.

OUTCOME

- 2023 Manufacturing Symposium to bring together manufacturing industries, government ministries, and other stakeholders in one room to discuss issues impacting the manufacturing sector and possible solutions to implement in order to address these issues.

Convened to facilitate discussion among members who possess SME-specific expertise and insights into what is essential for fostering a growth-enabling environment for their businesses. The aim was to address issues affecting SME growth and develop specific recommendations to be presented to the government for consideration when implementing policies supporting SMEs in the Solomon Islands.

OVERVIEW OF EXPORT INDUSTRY DEVELOPMENT (EIDO) 2023

Dialogue was with Kiribati Government representatives (Kiribati and Solomon Islands) and Kiribati Chamber of Commerce and Industry to better facilitate trade between Solomon Islands and Kiribati as biosecurity regulations negotiated by both countries had been approved for export of frozen products.
